



NEIGHBOR NETWORK CHALLENGE

Official Rules & Regulations

1. **Sponsor/Organizer** | The Neighbor Network Challenge is conducted by FISH of Sanibel-Captiva, Inc. (FISH), located at 2422 Periwinkle Way, Sanibel, FL 33957 (Mailing: P.O. Box 58, Sanibel, FL 33957)
2. **Eligibility** | The Neighbor Network Challenge is open to individuals 18 years of age and older. Employees, officers, volunteers, and directors of FISH and their immediate family members are eligible to participate.
3. **No Purchase Necessary** | No purchase or donation of any kind is necessary to enter or win.
4. **Promotion Period** | The Neighbor Network Challenge begins Monday, August 3, 2026, at 8:00 a.m. ET and ends Friday, August 7, 2026, at 5:00 p.m. ET. Entries received after the deadline will not be eligible.

6. **How to Enter** | During the promotion period complete the following. Participants may enter multiple times by visiting different participating businesses. **Limit one entry per business per participant.**
 - Visit a participating Neighbor Network business displaying the official Neighbor Network window sticker
 - Take a photo of the sticker or storefront
 - Share the photo by commenting on the FISH Facebook Neighbor Network Challenge post or by email to simon@fishofsancap.org. Include your full name, email address, phone number and preferred method of communication
 - Include the name of the participating business name
7. **Prize** | One winner will receive a gift card donated by The Magic Bus. The prize is nontransferable and has no cash value. FISH may substitute a prize of equal or greater value if necessary.
8. **Winner Selection and Notification** | One eligible entry will be selected at random on Monday, August 10, 2026. The winner will be notified via Facebook and/or direct message and/or email within five (5) business days. If the winner does not respond within seven (7) calendar days, another winner may be selected.
9. **Prize Pick Up** | The prize must be picked up at FISH of Sanibel Captiva, 2422 Periwinkle Way, Sanibel, FL, during normal business hours unless other arrangements are approved.



10. **Photo and Publicity Release** | By entering, participants grant FISH permission to use submitted photographs, names, likenesses, comments, and social media usernames for promotional, educational, and marketing purposes without additional compensation.

Participants represent that they own the submitted photograph or have permission to submit it.

Participants are encouraged to photograph only the Neighbor Network window sticker and storefront. If identifiable people appear in a submitted photo, the participant confirms they have obtained permission from those individuals, or from a parent or legal guardian for any minor, for the image to be submitted and used by FISH.

By entering, participants grant FISH a nonexclusive, royalty free license to use submitted photographs in print, digital, social media, and other promotional materials related to the Neighbor Network and FISH's mission. FISH may remove or disqualify any submission that violates these rules or the privacy rights of others.

12. **General Conditions** | FISH reserves the right to cancel, modify, suspend, or disqualify entries if fraud, technical issues, or other circumstances affect the intention of the promotion. All decisions made by FISH are final.

13. **Appropriate Content** | Entries must be respectful and appropriate for all audiences. FISH may remove or disqualify any submission containing offensive, unlawful, defamatory, or inappropriate content.

14. **Privacy** | Information collected during this promotion will be used solely for running the Neighbor Network Challenge and will not be sold or shared except as required by law.
